## CCOERA 2018 Scholarship Fund

### **Source of Revenue:**

\$100 each per Board meeting attended by Board members forgoing their individual compensation pursuant to 24-54-107.5 (3), C.R.S.

### **Disbursement of funds:**

Annually based upon achieving at least \$1,000 fund balance.

Awards are made each year (4-year maximum) at a minimum of \$500.

Checks will be sent made out to both the recipient and the college of his or her choice.

### **Eligibility Criteria:**

Current Participants; and

The dependants of current CCOERA Participants residing in Colorado who are current High school seniors or college undergraduates; and

Applicants must be U.S. citizens; and

No preference is given based on a student's choice of college or university, high school, city of residence or financial need. Relatives of Trustees, officers or employees of CCOERA are not eligible.

### **Use of funds:**

Any institute of higher education. Award will be in July after students graduate.

The award may be used for room, board, tuition or books and fees.

### **Application Process & Criteria:**

CCOERA will send out notices to all Employers/Participants describing the scholarship in February of 2018.

Students are asked to complete applications and return them by April 16, 2018.

The application must include an original essay, transcript and standardized test scores (ACT or SAT).

The 500-word count essay must include a statement why they believe they are qualified for this scholarship, their academic interests and other accomplishments and how this scholarship will aid them in their future academic efforts and their future goals.



CCOERA Scholarship selection criteria include:

- Scholastic Ability
- Evidence of Potential Leadership
- Service to Community and School
- Outstanding Character
- Letter of recommendation from associates, teachers, employers, coaches or mentors.
- Any other criteria the Board may consider

CCOERA Scholars may attend any undergraduate college or institution offering post-secondary education. There are significant differences between schools, and, ultimately, the decision about which school to attend must be based upon a Scholar's personal needs, future goals, intended field of study and individual preference. CCOERA suggests students tour the schools, visit with faculty and students, and research the wide variety of honors, leadership and research programs available at these institutions before making a commitment to any one school.

We are looking for students who have been actively involved in their schools and communities and who have demonstrated leadership, initiative and a high level of involvement throughout their high school careers.
